Practitioner Qualification

Achieve sufficient knowledge and understanding of the P3O° guidance to design, implement, manage or work within any component office of a P3O° model. You will have an overall understanding of the elements, roles, functions and tools and techniques deployed in a generalised P3O° model.

Suitable for anyone working in or managing offices within a $P30^{\circ}$ model or anyone who needs to create and implement a $P30^{\circ}$ model.

What You Will Learn

- $^{\circ}$ Develop the business case required to obtain senior management approval for the $P30^{\circ}$
- Identify and build the most appropriate P30° model, which will adapt to the organisation's needs, taking account of the organisation's size and portfolio, programme and project management maturity
- Identify the most appropriate roles required to populate a specified P30" structure
- Plan the implementation of a P30°
- Choose and use appropriate tools and techniques while running the P30° and advising those who shape the portfolio of programmes and projects

Foundation & Practitioner

The five day course combines P30° Foundation and P30° Practitioner enabling delegates to take both examinations within the same week.

The Foundation qualification is taught for 2.5 days with the examination on the third afternoon. The Practitioner qualification training follows with the examination on the afternoon of the fifth day. Delegates receive both levels of certification when the examinations are successfully passed.
